## 1. DUE TO ACCIDENT AND IIINESS

- For personal accident claim less than RM500 The doctor must certify the accident on the back page or attachment of the receipt and affix the signature of the doctor.
- For personal accident claim more than RM500 Pay medical report and medical nursing certificate.

In the event of an accident or illness, a student or parent/next of kin shall:

- notify the Student Affairs Office, Southern University College as soon as possible;
- provide information based on the checklist and attach any relevant supporting documents. Forms which are incomplete or without relevant supporting documents will not be considered;
- make copies of the supporting documents using A4-sized paper and certified by an officer from the Professional & Management Group (Doctor); and

Note: Insurance companies only recognize receipts and documents provided by registered qualified doctors / clinics / hospitals. General traditional Chinese medicine, massage and fall master treatment costs are not accepted by insurance companies. (Before seeing a doctor, must go to the western doctor and obtain a receipt to prove it before we can apply for a claim for the cost of traditional Chinese medicine treatment.)

## 2. DUE TO ACCIDENT DEATH

For death (due to accidental causes), claim, please use the same claim form and please submit requirements as below:

- 1. Fully Completed Claim Notification Form
- 2. Original or certified true copy of death certificate and burial/cremation permit
- 3. Original or Certified True copy of detailed post mortem / autopsy report where (applicable)
- 4. Police Report on the alleged accident
- 5. Both parents photocopy IC and student photocopy IC
- 6. Parents' marriage certificate
- 7. Newspaper cutting about the accident if applicable
